## SECOND AGREED MODIFICATION – AMENDMENT 2 of the COMPLIANCE AGREEMENT

## Purpose:

As provided by Paragraph M of the Compliance Agreement executed on January 13, 2014, this amends the Second Agreed Modification to the Compliance AGREEMENT as finalized on September 5, 2018.

This second amendment revises the Reclamation Schedule under Paragraph C and allows the adjustment to the reclamation schedule in the event any permit or permits listed therein are transferred or re-permitted by DMME to a third party.

### **AGREEMENT**

DMME and the Southern Coal by their signatures agree to amend the Second Agreed Modification as follows –

A. Paragraph C of the Second Agreed Modification is amended to revise the "Complete by" dates for Permit Nos. 1101953, 1102059, 1102058 and 1102052 as noted herein -

- 1. Reclamation of all areas of Permit No. 1101953 to be completed by December 31, 2019, with trees and shrubs planted by March 31, 2020.
- Stream channel mitigation to be completed and all applicable areas of Permit No. 1102059 vegetated by December 31, 2019, with trees and shrubs planted by March 31, 2020.
- 3. Backfilling and regrading of Permit No. 1102058 by October 1, 2019. Reclaimed areas to be vegetated by November 30, 2019, with trees and shrubs planted by March 31, 2020.
- Backfilling and regrading of Permit No. 1102052 by November 30, 2019.
   Reclaimed areas to be vegetated by December 31, 2019, with trees and shrubs planted by March 31, 2020
- B. In the event that a permit listed in the above Reclamation Schedule is transferred or repermitted by DMME to another company not affiliated with Southern Coal, the schedule will be adjusted accordingly to move forward the reclamation schedule for the remaining Southern Coal permits.
