RE: WVHC acknowledgement letter 7-3-24; South Fork Coal Co. Permits

Dear Principal Deputy Director Buccino, Regional Director Shope, and Mr. Flesher,

Thank you for your continued engagement on this package of issues. The West Virginia Highlands Conservancy (WVHC) and Allegheny Blue Ridge Alliance (ABRA) greatly appreciate your efforts.

Please accept this ten-day notice request on behalf of the WVHC and ABRA. The West Virginia Department of Environmental Protection (WV DEP) is improperly implementing the Surface Mining Control and Reclamation Act (SMCRA) by failing to effectively ensure compliance from South Fork Coal Company. Each second that South Fork Coal Co. pollutes pushes the candy darter closer to extinction.

In the email from 6/20/2024 (attached) the following SMCRA permits were mentioned: S301219, O302211, S303393, S301016, S300219, U301991, O301211, S300511, S01387. All of these permits drain into designated critical habitat for the endangered candy darter, and some permits are adjacent to or within the Monongahela National Forest.

We suspect numerous ongoing violations of differing natures for many, if not all, of the aforementioned SMCRA permits. In addition to the failure to implement Protection and Enhancement Plans (PEPs) for the candy darter on all of these permits, as required by the 2020 Biological Opinion, and the apparent 30 CFR § 761.11 / W.Va Code § 22-3-22(d)(5) / 30 U.S.C. § 1272(e)(2) noncompliance with O302211 (Haulroad #2), WV DEP has been extremely lax on enforcement and oversight with South Fork Coal Company. WV DEP continues to let severe water quality-based violations occur and remain uncorrected for far longer than the 90-days allowed, sometimes for years and with little to no civil penalties. Furthermore, after a site visit on June 26, 2024, during the permit renewal process for the long abandoned and reclaimed South Fork Deep Mine No. 2 (U301991), our concerns about the permanent toxic mine drainage issues present within the rock strata being mined at the headwaters of the South Fork Cherry River were confirmed, please see the attached photograph taken by WV DEP as it speaks for itself.

To understand the process mentioned in the acknowledgement letter, we would appreciate clarification from OSMRE on what is being investigated for each respective permit. Given the extensive record of violations, widespread noncompliance, and the sensitivity of resources present, we respectfully recommend that each permit held by South Fork Coal Co. that drains to candy darter critical habitat undergo complete review, as well as site inspection by the Office of Surface Mining Reclamation and Enforcement (OSMRE) accompanied by the U.S. Fish and Wildlife Service (FWS) (and US Forest Service Representatives, if applicable). Finally, OSMRE should seriously consider withdrawing delegation of SMCRA primacy for, at least, the permits in candy darter critical habitat, if not for the entire state. Right now, many permits exist in a perpetual state of violation and WV DEP is plainly not up to the task.

The aforementioned SF Coal Co. permits have had violations extended far beyond the 90-days allowed, meeting none of the qualifying criteria described in WV 38 CSR2 20.2e, which has created numerous violations of that code and requires a cessation order and \$750 per day civil penalty assessment, but with little to no action taken by WV DEP. The permits and violations identified by us are only a sample of the issues here. It is highly likely that with further investigation by OSMRE into these SMCRA permits, many more violations at these facilities would be found, and some permits may even be revoked.

<u>Rocky Run Surface Mine (S301219):</u> NOV 16, NOV 17 and NOV 18 extended far beyond the 90 days allowed and should be receiving a \$750 per day fine and cessation order.

Blue Knob Surface Mine (S300511): This permit's entire violation history and oversight process by WV DEP warrants review from OSMRE. NOVs 7, 10, 12-26 are a series of interconnected, unresolved violations, FTACOs, IHCOs, Consent Decrees and Show Cause Orders where violations have remained extended for years in some circumstances with no termination or structure to the civil penalty process. There does not appear to be any cohesive resolution process for the violations on Blue Knob, despite it having its SMCRA permit renewal waived by WV

DEP. For the recent Show Cause #2186, it appears that WV DEP's only requirement for a company to show cause is that it abates the violation, regardless of how many violations the company has, how long the violations have remained unabated, or whether the company has paid their fines. This does not seem to be in line with SMCRA's requirements, or with the expectations that come with delegation of SMCRA primacy to WV DEP. We are concerned this site is contributing permanent toxic mine drainage to candy darter critical habitat and native brook trout streams.

Lost Flat #1 (S013878): NOVs 29, 30, 31, 36, 37, 38 should be reviewed and NOVs 39-42 specifically warrant follow up given that they are nearing the 90-day limit. Many of the now terminated NOVs (pre-NOV 39) on this permit were unjustifiably allowed to remain open for a year (or more) in many cases, with little to no civil penalties issued or escalated oversight actions taken by WV DEP. We are also concerned with observed permanent toxic mine drainage issues with this operation.

Lost Flat #2 (S303393): Ongoing toxic mine drainage is impacting Becky Run from NPDES Outlet 032. Becky Run is one of the many small native brook trout streams that drain to the South Fork of Cherry River. Elevated sulfate and conductivity values indicate that Becky Run is affected by mine drainage. Conductivity values in Becky Run exceed the USEPA benchmark for protection of aquatic life in the central Appalachian region. Becky Run and three other streams in the Blue Knob-Lost Flat mine area have been listed by the WV DEP as impaired based on iron concentrations. Elevated selenium concentrations have been reported for Becky Run and other streams in the mine area.

The Lost Flat # 2 NPDES Outlet 032 is a source of mine drainage in the Becky Run watershed. South Fork Coal Company was issued a NOV on 7/4/16 for failure to comply with effluent limitations for iron at Outlet 032. Samples were collected while the mining company was engaged in backfilling highwall and pumping water from pits. The same NOV also cited the company for failure to meet effluent limits for aluminum at Outlet 004, which also drains to Becky Run. Figures 2a and 2b (attached as Lost Flat 032 Fe) provide plots of average monthly iron concentrations and maximum daily iron concentrations at Outlet 032 for the period, 2017-2022. Effluent limits were exceeded multiple times, mostly during the later part of the period. During the last 24 months of the period, average monthly iron concentration exceeded permit limits 13 times and daily maximum iron concentration exceeded permit limits five times. In addition, during the last three months of the period, permit limits for aluminum were exceeded two times and for manganese one time. This pattern does not appear to have improved in the time since.

Laurel Creek Contour Mine No. 1 (S301016): This mine has been inactive, from what we can tell, since approximately 2019. Despite this, on our recent flights over this mine, there are highwalls and other land disturbance that remains obviously un-reclaimed after many years. NOVs 8-10, issued in April 2024, are fast approaching the 90-day limit and should be monitored by OSMRE to ensure compliance. There have also been noted selenium excursions with this mine, adding further importance to our concerns about toxic mine drainage associated with mining in this area.

<u>Pretty Ridge Surface Mine (S300219):</u> Many NOVs on this mine were allowed to be extended for <u>years</u> without being terminated, with minuscule fines, and with little to no enforcement escalation by WV DEP. A complete review of the violation history on this mine by OSMRE is recommended to understand that South Fork Coal Company is incapable of ever complying with their permits in candy darter critical habitat. These negative impacts are being exponentially increased due to the feckless, incompetent oversight by WV DEP. Our concerns are particular to, but not limited to, NOV 5, 11, 12, 15, 16, 17, 19, 21, 24, 26, 27, 28, 29, 30, 32, 33, 34, 35, 37.

SF Deep Mine 2 (U301991): This mine is abandoned and has been reclaimed. The company claims it has not been mined for more than 17 years (see "Response to WVHC") and that reclamation has occurred at much of the mine site. There have been no active extractive activities under the permit, and there haven't been for many years. Despite this, there is clear evidence of permanent toxic mine drainage from this permit directly impacting the South Fork of the Cherry River (refer, again, to the attached photo 0067). Furthermore, during our site visit on 6/26/2024, when we walked the perimeter of the permit, we pointed out numerous issues to WV DEP. There were unexplained tubes leaving pond 2 that had recently had dirt piled over them but appeared to be discharging outside of a permitted outlet (see other attached photo 0069). WV DEP Claimed they could not inspect off the permit boundary and refused to allow us to go inspect further because it would have been outside of the permit area. Pond 1 was entirely nonfunctional as the drainage ditches had been rerouted to flow off the permit boundary without going through any control devices (see NOV 5). It is also suspected that South Fork Coal Co. is using this permit area to conduct chemical treatment at Rocky Run (where in the NPDES permitting for Rocky Run the company committed to not implement chemical treatment).

<u>Haulroad #1 (O301211)</u>: NOVs 9, 10 remain open beyond the 90-day allowed limit and should be receiving the \$750 per day fine and cessation order.

Haulroad #2 (O302211): The major concern is non-compliance with 30 CFR § 761.11/ W.Va Code § 22-3-22(d)(5) / 30 U.S.C. § 1272(e)(2), but the pattern of violations for NOV's 1-8 are deeply concerning. These repeated similar violations on Haulroad #2 (but occurring across all the company's haul roads) show a constant theme of disregard by the South Fork Coal Co., and insufficient oversight by WV DEP. WV DEP's justification for not issuing a show cause order after NOVs 4-6 was solely because NOV 5 had a negligence score of 1 (see attached "negative pattern determination"). We are unconvinced that this reasoning is sufficient to justify DEP's conclusion of a negative pattern determination. Furthermore, ABRA submitted a WV Freedom of Information Act Request to WV DEP for documents produced in connection with W. Va Code § 22-3-22(d)(5) for this SMCRA permit. In response, WV DEP provided only general permit documents and no documents specifically produced in connection with W. Va Code § 22-3-22(d)(5) for the portion of the permit that is within the Monongahela National Forest. In fact, the materials submitted by the company falsely claimed that none of the permit was within or adjacent to National Forest lands. This leads us to believe the required analysis was never conducted, that Haulroad #2 (O302211) was therefore improperly permitted, and that the permit should be vacated by OSMRE.

Finally, we reiterate the request that OSMRE conduct a full review of these permits, and conduct oversight inspections across all South Fork Coal Co. permits. For inspections OSMRE conducts on these permits, we also request that WVHC be allowed to have representatives present.
